**SECTION 1**  
**DOUGLAS COUNTY FAIR & RODEO COMPETITION RULES**  
**APPLIES TO ALL DIVISIONS, DEPARTMENTS AND COMPETITIONS**

**I. INTRODUCTION**

- A. The following terms, conditions, and rules apply to all departments and to all competitions at the Douglas County Fair & Rodeo.
- B. Every exhibitor or competitor at the Douglas County Fair & Rodeo shall comply with the competition rules herein and comply with the more specific rules set forth in each Department.
- C. Any person who violates any of the Competition Rules herein, may be subject to discipline as set forth in these rules and may be vacated or removed and ineligible for competition.
- D. Smoking is not allowed in any public buildings, or within 100' of any building entrance.
- E. Alcohol will be sold in designated areas on the Fairgrounds during the Douglas County Fair & Rodeo. Alcohol cannot be consumed or carried outside premised areas designated by signage.
- F. Any public display of photos or video of any Douglas County Fair & Rodeo event, concert, or rodeo for public dissemination without express written consent from the Douglas County Fair & Rodeo Management is strictly prohibited.
- G. All guests, contestants and participants are subject to a search by security personnel.
- H. The current Douglas County Fair & Rodeo Competition Rules will be posted on [www.douglascountyfairandrodeo.com](http://www.douglascountyfairandrodeo.com).

**II. GENERAL COMPETITION RULES**

- A. The Douglas County Fair does not discriminate on the basis of race, creed, color, sex, age, or other non-merit factors.
- B. Sleeping in livestock and horse barns are strictly forbidden.
- C. No fireworks are allowed.
- D. Warning: Under Colorado law, it is a crime to sabotage or to tamper with, administer growth stimulation drug(s) to, or substitute unauthorized animal(s) for exhibition livestock, pursuant to CRS Section 18-9-10 7. Penalties include up to eighteen (18) months in prison or a fine up to one hundred thousand dollars (\$100,000) and the name and photograph of any convicted person (s) to be available for publication in newspapers and trade journals.
- E. Warning: Under Colorado law, equine or llama professionals and activity sponsors are not liable for any injury to or death of a participant in equine activities resulting from the inherent risks of equine activities pursuant to section 13-21-119, Colorado Revised Statutes.
- F. Douglas County Fair & Rodeo Management is not responsible for any loss, damage or injury to any person or property while on Douglas County grounds or real property.
- G. An exhibitor or competitor acknowledges and agrees to abide by all Competition Rules when they sign up to participate in any way in the Fair and anyone who has not done so will not be allowed to participate.
- H. **Exhibitors and competitors hereby indemnify the Douglas County Fair & Rodeo Management from any and all legal proceedings in regard to a challenge to any Competition Rules.**
- I. Exhibits must be stalled, penned, or exhibited only in areas and locations assigned to that exhibitor by Douglas County Fair & Rodeo Management. Exhibits not in authorized locations will be removed

by the Douglas County Fair & Rodeo Management without notice and the exhibitor may be subject to disciplinary action.

- J. Exhibits may not be removed prior to 5:00pm on the final day of Fair.
- K. Every animal or article shall be entered and exhibited in the name of its bona fide owner.
- L. Douglas County Fair & Rodeo Management reserves the right to cancel events or change scheduling if deemed necessary. Specific or special competition rules or conditions are published in each department where necessary.

### III. DEFINITIONS

- A. Douglas County Fair & Rodeo Management: this term includes the Fair Board Directors, Fairgrounds Manager, Fair Coordinator, Superintendent, administrative staff, however the primary enforcement of these Competition Rules on a day-to-day basis is the Fair Board.
- B. Department Superintendent/Assistant Superintendent: Person appointed by Fair Board that oversees a specific department, division, or contest at the County Fair.
- C. Judge: an individual who is selected to judge items or animals based on his/her expertise.
- D. Junior Division Exhibitor: Douglas County 4-H Member and/or Douglas County FFA member competing in the Douglas County Fair and Rodeo.

### IV. ENTRIES & ENTRY FORMS

- A. Competitions are open to the world except where otherwise specified.
- B. All entries must be completed on regulation forms, properly filled out.
- C. Entry forms for Open Class Division Competitions are available at the Douglas County Fairgrounds Office prior to entry day. On entry day forms and assistance will be available at the Events Center during entry hours.
- D. No article will be entitled to a place on the grounds until proper entry has been made.
- E. Douglas County Fair & Rodeo Management assumes no responsibility for errors on the entry forms.
- F. Every participant expressly understands and agrees that a completed entry form is acceptance of these Competition Rules and further agrees and understands that they will abide by these Rules throughout the duration of their time at the Douglas County Fair & Rodeo. It is understood that non-compliance with these Competition Rules may subject any participant to penalties up to and including exclusion from future participation.
- G. Late entries will not be accepted.
- H. The Douglas County Fair & Rodeo Management reserves the right to limit entries to facilities available, and to cancel any Department, division, or class in which, in its judgment, the entries are insufficient to secure adequate competition. The Douglas County Fair & Rodeo Management further reserves the right to return entries in the event any event competition, class or exhibit is cancelled.
- I. Customary care will be taken in handling entries. Entries will be shown at the artist's own risk.
- J. Open Class Division premiums will be paid in cash on the final day of Fair or must be picked up no later than one month after the Fair of the current year. Cash premiums not picked up by that date will be forfeited and returned to the General Fund of the Fair.

## **V. EXHIBITOR AND COMPETITOR CONDUCT**

- A. The Douglas County Fair & Rodeo Management expects all participants (including exhibitors, competitors, parents, volunteers, etc.) to abide by the stated Competition Rules for all activities and events, including, but not limited to the following:
  - 1. Conduct themselves in a courteous, respectful manner, using appropriate language, exhibiting good sportsmanship and providing positive role models.
  - 2. Adhere to Competition Rules, curfews and dress codes
  - 3. Abstain from illegal and immoral behavior
  - 4. Fully participate in scheduled activities
  - 5. Refrain from physical or emotional child abuse or neglect
  - 6. Apply safety regulations to individuals, groups and property; and
  - 7. Accept personal responsibility for behavior.
- B. Consequences may include penalties as set forth in these Competition Rules.

## **VI. DISPUTES**

- A. The Douglas County Fair & Rodeo Management are the final review and authority to interpret these Competition Rules and to settle questions of interpretation.
- B. There are additional specific competition rules set forth, if necessary, within each Department's competition section. Both may apply and if there is a conflict between them the Department rules will apply.
- C. In the event that references to external requirements, regulations, or rules conflict to these Douglas County Fair & Rodeo Competition Rules then the Douglas County Fair & Rodeo Competition Rules shall control over such conflicts.
- D. The following three types of disputes are addressed in the following:
  - 1. Pre-Fair rule infraction/violation.
  - 2. During Fair rule infraction/violation.
  - 3. Exhibitor, competitor, or contestant-initiated protest.
- E. Failure to meet the dates or deadlines set forth in these rules, subsequent to those published in attachments too, are not grounds for disputes. All deadlines must be adhered to, see Appendix A: Master Schedule.

## **VII. DETERMINATION OF VIOLATIONS/PENALTIES**

- A. Whenever a violation of any competition term or Competition Rule has occurred or has been reported to have occurred, prior to or during the Douglas County Fair & Rodeo, it shall be reported first to the Department Superintendent, if possible for resolution, who will then elevate it to the Douglas County Fair & Rodeo Management if need be, to determine if, in fact, a violation has occurred. Only alleged violations reported within 24 hours of their occurrence will be investigated. If the Department Superintendent is unavailable, the alleged violation shall be reported to the Douglas County Fair & Rodeo Management. Douglas County Fair & Rodeo Management reserves the right to take the actions provided herein at any time if it believes a potential violation of the Rules has occurred.
- B. If the Department Superintendent is unavailable, the alleged violation shall be reported to the Douglas County Fair & Rodeo Management.

- C. If in fact a rule infraction has occurred, the notified Douglas County Fair & Rodeo Management Representative shall inform the Fairgrounds Manager and the Douglas County Fair & Rodeo Board Chairman. If the infraction warrants an investigation, the Infraction Sub-Committee, identified in Section 1, XI, will be assembled to investigate and deliver a decision on the infraction.
- D. The Infraction Sub-Committee shall investigate the infraction, conduct interviews with the affected parties and determine a resolution of the issue and identify if any penalty, as identified in Section 1, VIII, shall be applied.
- E. If the Infraction Sub-Committee shall generate a written response to the affected parties for the resolution for the Douglas County Fair & Rodeo Board Chairman's describing the infraction and the Infraction Sub-Committee's resolution.
- F. The affected parties shall be notified of the resolution and be informed of any penalty that was invoked.
- G. The Infraction Sub-Committee will present the issue and resolution to the Douglas County Fair & Rodeo Board for information only and to identify if the rule in question requires revision in the Competition Rules. The decision of the Infraction Sub-Committee is final.

### VIII. POSSIBLE PENALTIES FOR RULE INFRACTIONS

- A. The following penalties may be invoked for rule infractions:
  - 1. Written warning.
  - 2. The exhibitor or competitor in question is disqualified and could forfeit entry and other fees, trophies, and awards.
  - 3. The exhibitor or competitor shall be barred from competition at the Douglas County Fair & Rodeo for a predetermined period of time that may include a lifetime suspension from competition upon the concurrence of the Douglas County Fair Board.
  - 4. The exhibit in question will not be sold in any sale at the Douglas County Fair & Rodeo to include the Junior Livestock Sale.
  - 5. In the case of an exhibit already sold at the Douglas County Fair & Rodeo, the exhibitor or competitor shall refund and return all sale proceeds in excess of market value to the Douglas County Fair & Rodeo. The Douglas County Fair Board after conference with the Buyer shall determine the disposition of the remaining funds.
  - 6. Any combination of the above stated penalties.

### IX. INFRACTION SUB-COMMITTEE

- B. The following Infraction Sub-Committee will be assembled to investigate and render a decision when required:
  - 1. The Vice Chair of the Fair Board who shall serve as the presiding officer of the Infraction Sub-Committee (Voting Member).
  - 2. Superintendent of the affected department (Voting Member).
  - 3. One Douglas County Fair Board Director at large (preferably with knowledge in the affected department) (Voting Member).
  - 4. Fairgrounds Manager or representative strictly as an advisory role, who shall not have a vote.
  - 5. Two additional Douglas County Fair Board Directors at large (if the Vice Chair of the Fair Board determines that the situation warrants additional assistance) (Voting Member).

### X. PROTESTS

- A. DECISIONS OF JUDGES ARE FINAL AND NOT ELIGIBLE FOR PROTEST.
- B. Whenever any person believes that an exhibitor, competitor, contestant, parent, or Fair Official has engaged in any activity that violates the Competition Rules of the Douglas County Fair & Rodeo or engaged in any unethical activity during the course of the competition that may violate these rules, such person has the opportunity to provide their allegations of wrong-doing (protest) to the Douglas County Fair & Rodeo Management for review. Any person making such report must do so in writing (within 24 hours of the alleged infraction) and it must be personally presented to the Department Superintendent or a Douglas County Fair & Rodeo Management representative.
- C. Any protest must be accompanied by a one-hundred-dollar (\$100) bond (the "bond") payable to the Douglas County Fair Foundation.
- D. The following is the Protest Procedure:
  1. The protest must be presented, in writing, and sworn to, within 24 hours or sooner, of the occurrence of alleged infraction for all activities and prior to the official closing of the Douglas County Fair & Rodeo.
  2. In the event a protest is presented after the judging has begun on the item or activity in question, the judging will proceed, and the protest will be handled as if the protest has been presented following the judging.
  3. The written protest must state the name of the exhibitor, competitor, contestant or fair official as applicable, who has allegedly committed a violation, or identified by the activity in question when the name is unknown to the reporting party. The protest shall include the exhibit, class in question, the specific allegations giving rise to the protest, the facts that support the protest with reference to Competition Rules as applicable.
  4. Upon receipt of a properly presented protest, the Douglas County Fair Board will appoint the Infraction Sub-Committee, identified in Section 1, XI, to review the protest and render a decision, the review process may include interview with the parties involved to assist in obtaining the facts associated with the filed protest.
  5. The decision on the Infraction Sub-Committee is final. (Written notice or record of the decision).
  6. In the discretion of the Infraction Sub-Committee, the bond may be returned to the individual who posted the bond or retained. If retained, the bond will be deposited in general funds of the Douglas County Fair Foundation.

### XI. CONCESSIONS AND ADVERTISING PRIVILEGES

- A. All exhibits, concessions, or commercial privileges are at the sole discretion of Douglas County Fair & Rodeo Management. Under no circumstances will any advertising matter be allowed to be placed upon buildings, trees, or other places on the grounds, or otherwise distributed, without management permission. Unauthorized advertising material may be immediately removed and disposed of, without recourse or notice.

### XII. DOGS

- A. Dogs are not allowed on the Fairgrounds during the Douglas County Fair & Rodeo with the following exceptions:
  1. Service Animals.

2. Dogs on leashes will be allowed in the camping and trailer parking areas only. For their safety, dogs should not be tethered to a camper. A self-contained kennel is required for dogs staying in the camping area.
3. Excessive barking or complaints of aggressive behavior will result in the dog being excused from the Douglas County Fairgrounds. Excused dogs must be immediately removed from the Douglas County Fairgrounds.
4. Dogs that are competing or performing during the Douglas County Fair & Rodeo. Owners / Handlers must keep dogs under constant control and dogs ARE NOT allowed into any livestock barns, Kirk Hall, or the Events Center.

### **XIII. MOTORIZED UTILITY VEHICLES**

- A. NO personal golf carts or ATV's nor bicycles will be allowed on the fairgrounds during the Douglas County Fair & Rodeo.

### **XIV. OBJECTIONABLE EXHIBITS**

- A. The Douglas County Fair & Rodeo Management reserves the right to exclude from the grounds, any exhibit, animal, or entry that may be falsely entered, those deemed undesirable or objectionable, without assigning a reason.

## SECTION 2

### OPEN CLASS DIVISION ADDITIONAL RULES

#### ARTS, CRAFTS, CULINARY, AGRICULTURE AND FLORICULTURE CONTESTS

#### APPLIES TO ALL DEPARTMENTS AND ARE IN ADDITION TO ANY DEPARTMENT, DIVISION AND CLASS

### I. DEPARTMENT PROVISIONS

- A. The following terms, conditions, and requirements apply to all Open Class Division Departments at the Douglas County Fair & Rodeo. These rules do not supersede or negate the Douglas County Fair & Rodeo General Competition Rules. All exhibitors must be familiar with all Douglas County Fair & Rodeo Competition Rules. Additional and specific Competition Rules are set forth within each individual Department's sections. Both general and specific Competition Rules shall apply to all competitions unless specifically noted otherwise.
- B. Every exhibitor entering into any competition at the Douglas County Fair & Rodeo shall comply with the Competition Rules as set forth below and shall comply with any additional or specific requirements or regulations as set forth for each, individual competition. Submission of an entry to the Douglas County Fair & Rodeo expressly binds the exhibitor to all terms and conditions contained in any and all parts of the Douglas County Fair & Rodeo Competition Rules.

### II. GENERAL COMPETITION RULES:

#### A. EXHIBITOR CLASSIFICATION:

1. The amateur and professional definitions are applied to the classes being entered. A person may be both an amateur and a professional (example: In the Crafts Department an exhibitor can be a professional in the Stained Glass class but an amateur in the Macrame class.). Professionals are not eligible for Best of Show or Best of Category awards.
  - a. **AMATEUR** – A person who engages in an activity as a hobby, not as a job.
  - b. **PROFESSIONAL** – A person with professional training; or an instructor; or a person who participates for gain or livelihood in an activity often engaged in by amateurs; or a person who pursues the activity as a full-time occupation.
2. Age classification is determined as of August 1 of the current year. School grade classification is determined by the last grade completed as of August 1 of the current year.
  - a. Youth – 18 years & under as of August 1 of current year.
  - b. Open – 19 years & over as of August 1 of current year.
  - c. Senior Citizen – 55 years & over as of August 1 of the current year.

### III. ELIGIBILITY:

- A. **ELIGIBILITY:** Open Show Competition is open to the world, any group or individual.
  1. Youth exhibitors do not have to be enrolled in 4-H and may choose to be classified as Youth or Open for any entry in the Open Class Division. 4-H Youth Exhibitors are eligible and encouraged to enter current year items in Open Class as well as 4-H.

2. Articles or Items that have been exhibited in the Open Class Division at a previous Douglas County Fair & Rodeo are not eligible for competition at the current Douglas County Fair & Rodeo.
3. Junior Division Exhibitors who are Members in Good Standing may enter exhibits in the Open Class Division that competed in the Junior Division of last year's Douglas County Fair.
4. The exhibitor's or the minor exhibitor's parent/guardian's signature is required to certify that the entry is the exclusive work of the exhibitor.
5. The exhibitor's or the minor exhibitor's parent/guardian's signing the competition entry form(s) certifies that he or she has read and has been advised of the Douglas County Fair & Rodeo General Competition Rules, Open Class Division General Competition Rules, and special Department or Division Competition Rules.
6. All entries must be the work of the exhibitor.
7. Articles must be entered in the name of the person who made them.
8. Exhibitor signature certifies he or she has observed and agrees to Competition Rules regarding sabotage, tampering, prohibited substance, unethical fitting and agrees to observe and abide by all Competition Rules.
9. For the Open Class Division Llama/Alpaca Competition Rules, see the Junior Division Competition Rules, Department 27 Llama and Alpaca.

### IV. ENTRIES:

- A. Exhibitors are limited to one (1) entry per class, unless stated otherwise in the specific Department Requirements and Regulations.
- B. An exhibitor number will be assigned to each Exhibitor. This exhibitor number is to be used when entering all Open Class Departments. The exhibitor number must be on every entry form.
- C. Advance entries are NOT required for all Open Class Division.
- D. No article will be entitled to a place on the grounds until proper entry has been made.
- E. Superintendents and Judges may add, combine, or divide classes as necessary.
- F. In all classes entries will be judged and awarded on merit.
- G. Superintendents and Judges may move an entry to a different class/department if it has been wrongly entered or the entry would classify more correctly into a different existing class.
- H. Subject matter of entries must be appropriate for family friendly viewing. Inappropriate content or that which may be offensive to Fair patrons will not be accepted.
- I. The Douglas County Fair Board reserves the right to limit entries to facilities available and to cancel any department, division, or class in which, in its judgment, the entries are insufficient to secure adequate competition. The Douglas County Fair Board further reserves the right to return entries in the event any competition or class is canceled.
- J. The Douglas County Fair Board reserves the right to vacate as ineligible for competition and order the removal of any entry that has been entered in violation of these General Competition Rules or of any specific competition Rule.

**UNCLAIMED EXHIBITS:** Unclaimed exhibits will only be held for two weeks after Fair of the current year at the Douglas County Events Center Office, 500 Fairgrounds Drive, Castle Rock, CO 80104. After this deadline any unclaimed exhibits will be disposed of, and any unclaimed premium money will be forfeited and returned to the general funds of the Douglas County Fair.

The open class agriculture exhibits provide an opportunity for fair entrants to display the results of hard work cultivating farms and gardens and for attendees to learn about food and forage production in Douglas County and the region. Agriculture is a part of the heritage of Douglas County, and it is in its future too! While the motives for entering the agriculture division will vary from person to person, the purpose of the exhibits and friendly competition is to educate, inspire, and build up the gardening community. Most importantly, an agriculture show is FUN – whether you're an old-hand exhibitor or a novice, a blue-ribbon winner or not – relax, learn, and have fun.

Unless otherwise noted, exhibits in classes 18 and above must be entered on clear plastic plates.

## 2025 Douglas County Fair & Rodeo Open Class Competition Rules

- A. The Fruit, Herb, and Vegetable classes will be judged on freshness, uniformity, flavor, color, texture/firmness, and maturity as applicable. Individual exhibits must consist of all the same ripeness or greenness, and variety, as appropriate. For all classes follow rules and instructions for specifics: Number needed, height, weight, diameter, or length limits; trimmed or not; peeled: husked, or shelled; with or without stems, etc. For more appealing display, prepare exhibit as you would want to buy them: clean, not washed, free of foreign matter.
- B. 6" and 9" clear plastic plates will be provided.
- C. Herb stem length should be appropriate to herb variety (about 6-12"), except as noted. Herb foliage with or without flower according to conventional use.
- D. Fruit should have soil removed without scrubbing, polishing, or otherwise removing the natural "bloom".
- E. See additional rules in each division.
- F. Your entry may be reclassified.

### HELPFUL HINTS

- A. Display in cartons. When cracked, egg white (Albumen) should not run, yolk should be high with no bloodspots. A deep golden yellow yolk is preferred to a light-yellow yolk. All 6 eggs must be same color and uniform in size.

### HELPFUL HINTS

- A. Apples and Crabapples - Show with stems attached. Fruit should be mature as indicated by their aroma and color. Fruits should be uniform and without blemishes. Remove leaves.
- B. Chokecherries and Cherries – Show with stems attached. Color should be deep, dark purplish-red. Color, uniformity, and proper maturity are critical factors.
- C. Raspberries - Show with stems and calyx segments attached. Fruits should not be exhibited without hulls. Collapsed fruit and dispersing aggregates are signs of over maturity.
- D. Strawberries - Should be mature, uniform and exhibited with caps.

### HELPFUL HINTS

- A. Snap Beans: Pods should be well-formed, tender, firm and should snap when broken. Color should be bright, seeds should be small, and the flesh should not have any voids. Pods should be uniform in-shape and size with ½” of stem attached.
- B. Table Beets – Should have 1” petioles. Beet should be tender, smooth, free of side roots, have a small crown, and should be rounded, symmetrical and uniform. The root should not be removed. Size from 1” to 3.5” diameter.
- C. Broccoli – Stems are 6” and the head at least 3” in diameter. Stem should be solid and loose leaves removed. Head should be compact and dark green with tight uniform buds of medium size. No yellow color. Over maturity, looseness in head and damage to buds are to be avoided.
- D. Cabbage – Heads should be firm and solid with 2 to 3 wrapper leaves per head and small mid-veins, tightly formed. Stems should be cut ¼” below the head.
- E. Carrots – Should have 1” petioles remaining. Carrots should be small cored, straight, crisp and have deep color. The root should be clean and free of side roots. The skin should be smooth, the roots uniform and true to size and shape for variety. Avoid large crowns and green shoulders.
- F. Peas – ½ pound of podded peas with ½” stems attached. Select pods that are bright green and fully filled with well-sized but tender peas. Pods should be plump and firm and seeds sweet and tender.
- G. Cauliflower – One head at least 4” in diameter with 4 to 6 leaves to protect curd. Trim outer leaves slightly above head. The curd should be pure white, white, or color of cultivar, smooth, and compact. Avoid over maturity and openness. Stem should be trimmed ½” below the last remaining leaf.
- H. Garlic – Uniform, well-shaped and full sized. Brush off dirt, do not wash. Do not remove sheath. Cut off roots. Bulbs should have small, well-dried necks with 2” stem attached.

- I. Bulb Onions – Display with 2” to 3” of stem attached. Select uniform, solid, well-cured mature onions with intact dry skins and well-dried, tight necks. Harvest early and air dry thoroughly. Do not remove outer scales. Do not wash.
- J. Green Onions – ½” to 1” in diameter, clean, purple or white color, with dark green tops about 6” long. Remove loose skin, cut tops to 4” to 5” above white shank. The shanks should be long, straight and the bulb not enlarged. Peel only one outer wrapper. OK to wash. Trim roots to ½”.
- K. Potatoes – Firm, plump and no damage spots. Potatoes should be uniform with shallow eyes and smooth surface. Brush off dirt with soft brush. Do not wash.
- L. Tomatoes (unripe, green) – Should be uniform, firm and “mature green” with a slight pinkish color preferred to being green. Should be soil-free, but not washed or polished.
- M. Tomatoes (ripe) – Fruit should be uniform in size, color, firmness, and maturity. The interior bright and meaty with green gel around seeds. Tomatoes should be true to variety in size, shape, and color. The skins should be smooth and without growth cracks. Should be soil-free, but not washed or polished.
- N. Tomatoes (Cherry) – Fruits should be uniform in size, color, firmness, and maturity. Tomatoes should be true to variety in size, shape, color, and maturity.
- O. Leafy Greens – Dark green, crisp fresh leaves with bright, clean stems. Avoid dirty, wilted, poorly colored leaves with insect damage or the flowering stems present.
  1. Head of Lettuce – 1 Head – Crisp, good color, and firm. Trim stem evenly at base. Remove damaged outside leaves.
  2. Leaf lettuce – 3 Leaves – Tender, good color, clean, and fresh.
- P. Eggplant – Fruit should retain calyx cap and ½” of stem. A good quality eggplant is firm, heavy in relation to size, with a uniform color and small blossom scars. Should not be washed, but it should be cleaned with a soft cloth. Uniform color and patterning. Not overripe (seeds should not be brown/mature).
- Q. Turnips – Should be smooth with firm flesh, have a small crown, be free of side roots, round, crisp, and a color pattern typical of variety. They should be 2” to 2.5” in diameter with 1” petioles. The taproot should be untrimmed.
- R. Pepper (mild/hot) – ½” of stem should be attached. Fruit should be clean and firm with dark color (red, green, or yellow) and without blemishes. The peppers should be of uniform size and color, with even lobes (as applicable).
- S. Radishes – Should be smooth, firm, crisp, and free of side roots. Followed by uniform shape, color, and maturity. Should have 1” petiole remaining. The root should be clean.
- T. Rhubarb – Stalks should be uniform in size and color. Stalks should be pulled, not cut from plant. Leaf should be trimmed to show one inch of leaf at the end of each stalk.
- U. Vegetable Critter Art – Can be any parts of vegetables, including stems, leaves, and seeds. Fastened with small wood skewers only. No glue or tape. This is a great class for all children and adults!

### **HELPFUL HINTS**

- A. Cucumbers – Straight, uniform size and color typical of variety. Fruit should be crisp, firm, and free of insect or mechanical damage. Trim stem to ½". Wipe with soft cloth to clean.
  1. Pickling: 2" to 4" in length, with straight even spines.
  2. Slicers: 6" to 10" in length, not to exceed 2.5" in diameter. No mature seeds.
- B. Summer squash or Zucchini– Zucchini should be 6" to 9" long. Yellow or straight neck squash should be 5" to 6" long. Scalloped or pattypan squash should be 3" to 4" in diameter. Each entry should have ½" of stem attached, with the skin tender and seeds immature and edible. Flesh should be solid, light colored, and free of voids.
- C. Field or Pie Pumpkins – Pumpkins should have a thick flesh and be heavy for size. A 2" stem must be attached. Fruit should be smooth and mature, showing full ripe color. The skins should be resistant to thumbnail puncture. Wipe and polish with a soft cloth. Field pumpkins are any pumpkin grown for decorative purposes or as livestock forage, regardless of size; pie pumpkins are grown for human consumption.
- D. Winter squash – Should be mature and have 2" stem attached. Skin should be hard and soil free.

- A. Select sprigs with leaves that are clean and free of blemishes.
- B. Dill - Select large mature heads with green seeds “going” brown. Cut seed heads with 10” to 12” stems.

## OPEN CLASS DIVISION FLORICULTURE

### ALL EXHIBITS ARE IN THE EVENTS CENTER - JUDGING OPEN TO PUBLIC

During the fair in the floriculture open class display, gardeners and non-gardeners alike will see a wide variety of flowers, arrangements, and plants that can be grown in our region and beyond. This educational and inspirational opportunity is the purpose of the exhibition, allowing growers to display the fruits of their labor and to compare their results, commiserate in hardships, and enjoy camaraderie with other gardening enthusiasts. For many, the honor of displaying (and placing) in the competition is the only reward sought; for others, the prizes and awards, though small, are motivating. Whatever your own reason for exhibiting and visiting the division, **the goal of the show** is to inspire and educate, and for everyone, exhibitors and non-exhibitors alike, **to have fun.**

### I. DEPARTMENT PROVISIONS

- A. All entrants must read and be familiar with, and comply with, the Douglas County Fair & Rodeo General Competition Rules, Open Class Division General Competition Rules, and any special Division or Department Competition Requirements or Regulations.
- B. See Additional Instructions on Timing and Premiums in the Agriculture section.
- C. All exhibits must have been produced by the exhibitor. Plants in classes 10-73 must have been grown by the exhibitor for at least 2 months; plants in classes 77 and above for at least 3 months.
- D. Commercially grown cut flowers will not be eligible in classes 9-73.
- E. Commercially grown cut flowers shall be eligible in classes 1-8.
- F. Exhibitors may enter TWO (2) entries per class.
- G. Designations (unless otherwise noted):
  - 1. S – Small – under 3”
  - 2. L – Large – over 3”
  - 3. Follow rules of presentation for requirements such as ‘spray’ vs. ‘stem’.
    - a. Spray: A branched inflorescence with at least two open blooms and with or without buds.
    - b. Stem: A single-branched specimen with a single bloom and no other buds. (Compound inflorescences in the aster family are considered stems for the purposes of the show).
  - 4. Overall size – means in all directions, unless otherwise indicated.
    - a. Containers/planters do not count toward height in potted plant classes.
  - 5. Containers are furnished for small cut flower entries.
- H. Marijuana is prohibited in any agriculture or floriculture exhibit.

### HELPFUL HINTS

- 1. To prepare flower exhibits properly, cut with sharp pruners after sundown or in early morning. Cut at peak of maturity, that is, when the main bloom or blooms is/are  $\frac{3}{4}$  open.
- 2. Place immediately into tepid or warm water, and place in a cool dark place out of drafts for at least 8 hours prior to showing to allow time for the flower to recover full turgor.
- 3. Flowers that wilt easily should be collected the morning of the show.
- 4. Plants and cut flowers may be cleaned/groomed, though leaf dressing/shine is not allowed. Do not show plants with damaged leaves or spent flowers; they should be removed or trimmed as

inconspicuously as possible. (A small blemish on an otherwise perfect specimen, though, will not remove it from contention.)

5. All specimens should be clean, and free from insect and disease damage or other blemishes.
6. No leaves should be submerged in the display vase.
7. Plants should be properly labeled on the entry tag. Genus species (botanic name) is preferred to aid in classification, but common names are acceptable. Provide as much information as possible, including variety name (remember to save those nursery tags and seed packets for reference!).

Examples:

- Best: Tagetes patula 'Dwarf Sparky'
- Better: French Marigold, Dwarf Sparky
- Good: Marigold, Dwarf Sparky
- Acceptable: Marigold

8. How Judges Evaluate Entries: Entries are not judged against one another directly but are judged according to how closely each approaches the "ideal" for the variety. If no entries in a particular class are sufficiently close to the ideal standard, top placings may not be awarded at the judge's discretion. Entries may be reclassified if necessary—judges/superintendents may subdivide and combine classes at their discretion to make class size and judging more manageable and move incorrectly entered plants to the correct class in order to make entries competitive for awards.

In general, judges look at:

- i. Condition: Plants are at peak bloom and free from disease, insects, mechanical, or other damage, including dirt, stain, and blemish.
- ii. Form: Plants and flowers are at proper maturity and correct shape for variety.
- iii. Stem and Foliage: Stems should be straight and in proportion to flowers, not damaged.
- iv. Color: Color should be true to type, intense, and brilliant.

### **FINE ARTS – DEPARTMENT FA**

A. Exhibitors must use the following guidelines for framing and hanging artwork:

**Adult and Professional Division:** All Two-Dimensional Artwork **must** be ready to hang, dry, suitably framed, or matted and framed, and properly fitted with screw eyes or “D” rings and flexible picture hanging wire only. See examples shown below.

Oil paintings and acrylic-painted gallery-wrapped canvases must be dry at the time of entry and ready to hang using proper hanging materials as described with screw eyes or “D” rings and flexible picture hanging wire only.

**Youth Division:** All 2-D artwork **must** be matted and backed with cardboard or matboard. The mat and backing board must be sturdy enough to keep the artwork flat while it is hanging. No hanger is required, as we will furnish and use binder clips to hang the artwork, as shown in the examples below.

If the youth exhibitor chooses to frame, or mat and frame their work, they **must** follow the same hanging system requirements as described above in the Adult and Professional guidelines. If the youth exhibitor decides to compete in Adults and Professional division, they must follow the same hanging system requirements described in the Adult and Professional guidelines.

**All Entrants:** All artwork using clip mounts, string, tape, sawtooth hangers, hook holders embedded in cardboard backing, cardboard loops, or any other unstable hanging hardware, including missing wires, will not be accepted. Items that fall will be removed from view for the remainder of the fair for safety reasons.

Customary care will be taken in handling artwork, but it will be shown at the artist’s own risk.

- B. Fine Arts entries will be judged on technique, composition, color theory, originality, and overall presentation.
- C. Only traditional forms of fine art will be accepted and judged. **Entries must be original work designed and executed solely by the artist.** Work from commercial kits, paint-by-numbers or copied forms is not eligible. Digital or computer enhanced work will not be accepted or judged.

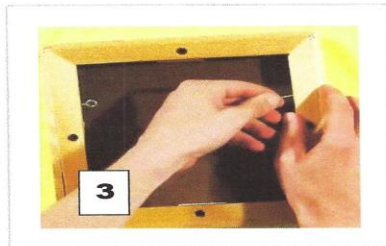
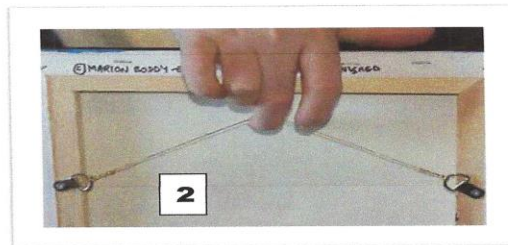

- G. Exhibitor Classification: The amateur and professional definitions are applied to the class being entered. A person may be both an amateur and a professional. Ex: In the Crafts Department an exhibitor can be a professional in Stained Glass but an amateur in Macrame. Professionals are not eligible for Best of Show or Best of Category awards.

**Amateur** – A person who engages in an activity as a hobby, not as a job.

**Professional** – A person with professional training; or an instructor; or a person who participates for gain or livelihood in an activity often engaged in by amateurs; or a person who pursues the activity as a full-time occupation.

- E. First time entries must be identified on the entry tag.
- F. Articles **must** be clean and free from odor, lint, soil, stains and pet hair. Please cover name labels attached to quilts.
- G. Youth Exhibitors:
  - 1. Youth exhibitors can enter any numbered class listed below as a youth and be judged against other youth in that class.
  - 2. Youth exhibitors can also enter by their grade completed as of August 1 of the current year and would be judged with a variety of entries and grades.
  - 3. Youth exhibitors can also choose to enter against adult exhibitors (not common).
- H. Exhibitor Classification: The amateur and professional definitions are applied to the class being entered. A person may be both an amateur and a professional. Ex: In the Crafts Department an exhibitor can be a professional in Stained Glass but an amateur in the Macrame. Professionals are not eligible for Best of Show or Best of Category awards.
  - Amateur** – A person who engages in an activity as a hobby, not as a job.
  - Professional** – A person with professional training; or an instructor; or a person who participates for gain or livelihood in an activity often engaged in by amateurs; or a person who pursues the activity as a full-time occupation.
- I. Quilt:
  - 1. Three Layers – top, batting, backing.
  - 2. Held together by quilting stitches through all three layers.
- J. **Quilt Classifications:**
  - 1. **Large Quilts:** Those that have a total perimeter measurement of 280" or larger.
  - 2. **Small Quilts:** Those that have a total perimeter measurement of less than 280".
  - 3. **Hand Quilted:** Quilts that are 75% hand quilted. Hand quilted quilts may include some machine quilting.
  - 4. **Machine Quilted:** Quilts that are 75% machine quilted. Machine quilts may include some hand quilting.
  - 5. **Mostly Pieced:** At least 75% of the surface of the quilt top is pieced by hand or machine.
  - 6. **Mostly Appliquéd:** At least 75% of the surface of the quilt top consists of appliquéd motifs applied by either hand or machine. Includes fused applique.

7. **Mixed Techniques (pieced & appliqued):** Any quilt top that consists of a fairly equal combination of piecing and appliqué.
  8. **Special Surface Design Techniques:** Quilts that consist of one or more other surface techniques such as embroidery (hand or machine), whole cloth, embellishments, photo transfers, memory quilts, panels, etc.
  9. **Miniature Quilts:** Quilts that are tiny scaled representations of full-size quilts. The piecing, applique motifs, fabric prints, quilting design, sashing, borders, and binding must all be miniature. Maximum perimeter measurement must be 70" or less. All surface techniques, quilting and finishing should be miniature in scale.
  10. **Group Quilts:** Combined efforts of three or more persons. At least one person must still be living.
  11. **Junior Quilts:** If 75% or more of a quilt is made by a Junior (age 18 or under) in collaboration with an adult, it may be entered in the Junior Quilts Division.
  12. **Art Quilt:** A contemporary artwork of original design involving the creative expression and exploration of various processes such as dyeing, printing, painting, stitching, embellishing, quilting, and weaving. An Art Quilt does not follow traditional block lines.

**Amateur** – A person who engages in an activity as a hobby, not as a job. Ex. An amateur artist does not receive income from works of art.  
**Professional** – A person with professional training; or an instructor; or a person who participates for gain or livelihood in an activity often engaged in by amateurs; or a person who pursues the activity as a full-time occupation. Ex. A professional artist sells or has sold their artwork, exhibits regularly or teaches art.

- B. Exhibitors must use the following guidelines for framing and hanging artwork.  
All Two-Dimensional Artwork **must** be read to hang, dry, suitably framed, or matted and framed, and properly fitted with screw eyes or “D” rings and flexible picture hanging wire only. See examples shown below.  
Oil paintings and acrylic-painted gallery-wrapped canvases **must** be dry at the time of entry and ready to hang using proper hanging materials as described with screw eyes or “D” rings and flexible hanging wire only.
- C. All artwork using clip mounts, string, tape, sawtooth hangers, hook holders embedded in cardboard backing, cardboard loops, or any other unstable hanging hardware, including missing wires, will not be accepted. Items that fall will be removed from view for the remainder of the fair.
- D. Customary care will be taken in handling artwork, but it will be shown at the artist’s own risk.
- E. Photography: Photos must be mounted on a black mat or paper only and suitable for hanging without additional frame. HINT: Use double sided tape instead of glue as glue does not adhere well.
- F. Overall size limit 11” x 14” black mat only. Only 5” x7” or 8” x10” prints are acceptable. NO names or watermarks are allowed on prints.
- G. Subject matter of entries must be appropriate for family friendly viewing.

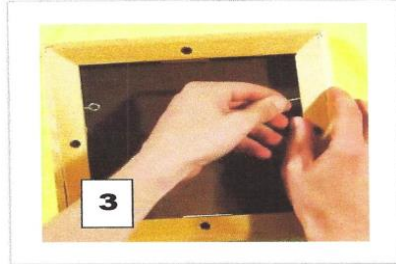
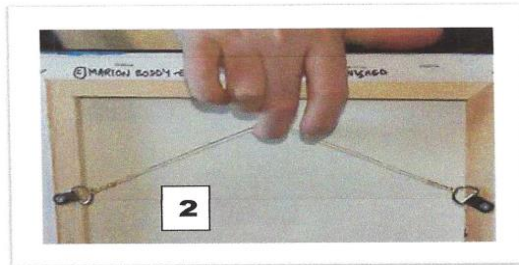
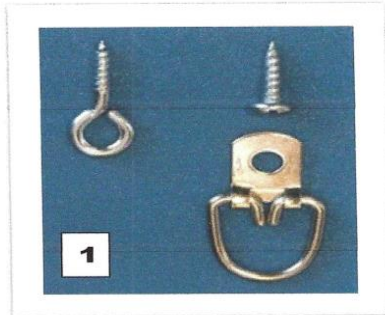
